Jean Ricci Goodman, M.D., M.B.A., is a Chicago southside native who graduated college at John Caroll University in Cleveland, Ohio before attending Georgetown University School of Medicine in Washington, D.C. She also holds a Master of Business Administration from George Washington University in Washington, D.C. Her residency in OB-Gyn and fellowship in Maternal-Fetal Medicine were both at the University of Miami/Jackson Memorial Medical Center in Miami, Florida.

Dr. Goodman began her academic career in the Dept. of OB-Gyn at the UCLA School of Medicine followed by almost 15 years as a perinatologist in a non-academic setting. She returned to academia at the University of Oklahoma Medical Center as an Associate Professor, followed by Loyola University Medical Center in Chicago as the Director of Maternal-Fetal Medicine and for the past three years, has been the endowed Professor and Chair of OB-Gyn at the University of Missouri School of Medicine, Columbia.

The recipient of numerous awards for teaching, service and research, Dr. Goodman has

excelled in women's healthcare at every phase of her career. Her list of committee appointments span several institutions as well as Chairing the Trinity Healthcare Women's and Children's Council, and editorial board member and reviewer for several medical journals. As a prolific researcher she

has been awarded over \$8 million in grant funding. The author of over 40 scientific papers, 75 scientific abstracts and 2 book chapters she has been an exemplary role model and mentor for medical students, residents, fellows and faculty.

Dr Goodman was elected to CAOG membership in 2009 where she served as membership committee chair and a 3 year term as trustee before being elected to the presidential track of succession. The CAOG is honored to present Dr. Jean Ricci Goodman as the 6<sup>th</sup> woman president in its 95 year history. She has our respect and admiration.

Meeting Report: Indianapolis, Indiana

## Indianapolis Meeting Report

The Central Association of Obstetricians and Gynecologists conducted its  $91^{st}$  Annual Meeting in Indianapolis, Indiana at the Hyatt Regency Hotel from October 16 - 19, 2024. The scientific program was developed through the year with the long hard work of the Scientific Program Committee chaired by Dr. Dani Zoorob, Secretary-Treasurer. Thanks to everyone for a great effort.

The 3 daily sunrise lectures and 22 podium oral presentations were interspersed with hot topics, invited lectures and a 2 day poster session to offer a diverse, lively and academic scientific program. The general sessions were awarded 17.00 CME I hours and 17.00 cognate credits from ACOG.

Hot topics highlighted the most up-to-date information on (1) the heart and cardiovascular health, (2) ways to improve maternity care, (3) menopausal therapy, (4) wellness-retention with building a sustainable healthcare workforce, (5) addressing increasing cervical cancer rates in the U.S. and (6) sexual health, the sex you don't know your patients are having. The Keynote Address, delivered by Dr. Jeanne Conry from Granite City, California, was titled "Hope for Maternal-Child Health Across the Globe: How the U.S. and Global Partners are Creating a Brighter Future."

The Presidential Address by Dr. David M. Haas, was a thought-provoking presentation titled, "Mentorship and Sponsorship: Keys to All Our Future."
